TSIU RIVER LODGE - Cordova, Alaska

The Tsiu River Lodge is located near game management areas 6, 11, and 13, near Cordova, Alaska. This area has a good population of brown bear, black bear, moose, and mountain goats. We also have great salmon fishing and duck and goose hunting. Some of my tours take place partly in the Chugach National Forest and BLM lands under a special use permits issued by the U.S. Forest Service and BLM.

How to get there: From the East Coast to Anchorage via Delta Airlines. From the Midwest and West Coast to Anchorage via Delta Airlines and Alaska Airlines. You can fly direct to Cordova from Seattle on Alaska Airlines, or from Anchorage to Cordova on Alaska Airlines. I will book your air taxi from Cordova to Tsiu River Lodge.

BEAR CAMP - Kodiak, Alaska

The Bear Camp is located on the South end of Kodiak Island, in game management area 8 near Olga Bay. It lies in some of the most prime Brown bear habitat on Kodiak Island. It is also rich in salmon streams, and offers a high density of brown bear as well as the highest concentration of Sitka Black Tail Deer on all of Kodiak Island. Some of my tours take place on Kodiak National Wildlife Refuge and Akhiok and Kaguyak Inc. lands under a special use permit.

How to get there: From the East Coast to Anchorage via Delta Airlines. From the Midwest and West Coast to Anchorage via Delta Airlines and Alaska Airlines. From Anchorage to Kodiak Island via Alaska Airlines. I will book your air taxi from Kodiak City to Bear Camp.

Services Furnished

Upon arrival at Base Camp: sleeping accommodations, all camp equipment, snowshoes, food and air-plane transportation. Licensed guide for each hunter, field care and arrangements for shipment of all trophies from Base Camp, and hotel arrangements.
